**III. VALUE ADDED TAX**

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

**IV. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
  
2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint during the entire service period. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
  
3. PROCEDURES.
  - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
  - (b) The COR will complete appropriate documentation to record the complaint.
  - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
  - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
  - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

V. INSURANCE REQUIREMENTS

1. Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this contract

The Contractor's assumption of absolute liability is independent of any insurance policies.

2 Insurance. The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this contract, whatever insurance is legally necessary. The Contractor shall carry the following minimum insurance:

General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

General Liability:	
(1) Bodily injury on or off site stated in local currency:

The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- a) any property of the Contractor,
- b) its officers,
- c) agents,
- d) servants,
- e) employees, or
- f) any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

3. Worker's Compensation Insurance. The Contractor agrees to provide all employees with worker's compensation benefits as required by the laws of either the country in which the employees are working or the employee's native country, whichever offers greater benefits, following FAR 52.228-4 "Worker's Compensation and War-Hazard Insurance Overseas."

## VI. PERMITS

The Contractor shall maintain in full force and effect all permits, licenses, and appointments required for the prosecution of work under this contract at no additional cost to the Government. The Contractor shall obtain these permits, licenses, and appointments in compliance with host country laws.

## VIII. SUBMISSION OF INVOICES

1. **Summary**

The U.S. Consulate requires a contractor to repair or replace several kitchens, bathrooms, and interior items such as floors at the 3 Barker Road Compound. The following is a list of rooms:

Barker 103 1 kitchen, 1 maid's bathroom, 1 storage, 3 full bathrooms, 1 half bathroom

PRICE #1: Kitchen and bathroom repair

PRICE #2: Wood floor replacement

PRICE #3: Electrical wire repair and replacement

The Consulate may opt to perform all or some of the proposed renovations. The Contractor will be selected on the lowest price, technically acceptable for whatever combination and quantity of rooms to be repaired.

**General Requirements**

The Contractor shall provide personnel, material, equipment, and supervision to complete the technical requirements in this Statement of Work. The Contractor shall be responsible for hiring necessary labor and equipment and managing subcontractors. All personnel shall follow security and safety directives as explained by the Consulate.

The Contractor shall have limited access into the building and outside the areas designated for the project except with permission by the Consulate. The Contractor shall address the impact of the consequent disruption and provide for a continuing level of operation of the U.S. Consulate functions caused by the proposed work.

The Contractor shall provide qualified or certified electrician per local law to perform the electrical work. Refer to EMSD department of Hong Kong.

Work can be performed seven days per week from 8am – 5pm. Noisy work can only be performed Mon – Fri and must be coordinated with events taking place at the Consul General's Residence.

2. **Scope of Work**

The U.S. Consulate requires a contractor to repair several kitchens and bathrooms at the 3 Barker Road Compound. The following is a list of rooms:

Barker 103 1 kitchen, 1 maid's bathroom, 1 storage, 3 full bathrooms, 1 half bathroom

PRICE #1: Kitchen and bathroom repair

PRICE#2: Wood floor replacement

PRICE #3: Electrical wire repair and replacement

## **PRICE#1: KITCHEN AND BATHROOM REPAIR**

### **Kitchen:**

#### **Demolition**

Completely demo and remove off-site all ceiling, lights, cabinets, appliances, floor tiles, countertops, wall tiles, backsplash, grout, sink, faucets, etc....

The Contractor shall provide at least 3 samples of floor tiles, wall tiles, countertops, backsplash, cabinets, sink, lighting, kitchen hood, and faucet.

#### **New Ceiling**

Replace the existing ceiling with a new ceiling to match the color and material of the old ceiling. Furnish and install new ceiling AC vents, lights, etc...

#### **New Tiles**

Floor tiles should be porcelain (minimum Class 3), a non-white light neutral color, and should be no larger than 30cm.

Backsplash tiles should be ceramic, non-white neutral tiles with a different color and design than the rest of the wall tiles. Tiles should be smaller than 20cm.

Wall tiles should be porcelain (minimum Class 2), non-white light neutral color, and should be no larger than 20cm.

Tile grout should be complementary to the tiles selected and should be the same for all tiles used. Non-white, neutral grout should be proposed.

#### **Countertops**

Kitchen countertops should be engineered quartz, minimum 3 cm thickness, with a non-white light to medium color that complements the kitchen tile selections. Countertops should be squared edges. Countertops surface should be 36" from the floor.

#### **Cabinet & Drawers**

New cabinets and drawer layout should be similar to the existing cabinet layout. The contractor should provide a dimensioned drawing of the proposed cabinets and drawers including the height, depth, and width of each item.

Cabinets doors should be flat (slab) face, acrylic with a medium, non-white color. The doors should be overlaid and designed to not require door or drawer handles.

Cabinet doors should be a neutral, non-white color complementary to the tiles and countertops.

#### **Sink & Faucet**

The kitchen sink should be a triple bowl, 16-gauge, 300 series stainless steel, undermount sink.

Faucet shall be chrome, high arc, single handle with a stainless-steel pull-down hose able to reach each of the three sinks. The faucet must be installed so that the handle does not touch the backsplash.

#### Kitchen Hood

Provide and install a vented metallic finish kitchen hood with a wire mesh filter. The hood should include a light switch and separate fan switch with high-medium-low options. The hood should be vented to the existing outside wall opening with new vent material. The front of the hood should extend to be in line with the full depth of the stove.

#### Lighting

Provide and install an LED tube light in the same locations as original lights. The LED light should be no less than 5000K color temperature.

All light switches should have stainless steel wall plates with black plastic rocker switch

#### Electrical Work

In addition to the electrical work associated with the water heaters, kitchen hoods, and lights, the Contractor shall replace all electrical outlets with GFCI outlets in GFCI outlets are not already installed. Additionally, there should be a total of 5 countertop GFCI outlets and additional outlets should be added if needed by the contractor. The outlets will be provided by the Consulate, but all electrical work, wall cutting, patching, and painting will be by the Contractor. No exposed wires or surface mounted conduit is allowed. Wires should be buried inside the wall as necessary.

#### Painting

The entire kitchen, pantry, and laundry room should be patched and painted upon completion of the work.

### **Family Bathrooms:**

#### Demolition

Completely demo and remove off-site all cabinets, kitchen door, floor tiles, sinks, toilets, showers, bathtubs, countertops, wall tiles, backsplash, etc...

The Contractor shall provide at least 3 samples of floor tiles, wall tiles, countertops, backsplash, cabinets, sink, lighting, toilet, tub, plumbing hardware, etc...

#### New Ceiling

Replace the existing ceiling with a new ceiling to match the color and material of the old ceiling.

#### New Tiles

Floor tiles should be porcelain (minimum Class 3), a non-white light neutral color, and should be no larger than 30cm and suitable for bathroom use.

Wall tiles should be porcelain (minimum Class 2), non-white light neutral color, and should be no larger than 20cm.

Tile grout should be complementary to the tiles selected and should be the same for all tiles used. Non-white, neutral grout should be proposed.

#### Countertops

Bathroom countertops should be engineered quartz, minimum 3 cm thickness, with a non-white light to medium color that complements the bathroom tile selections. Countertops should be squared edges. Countertops surface height should be in line with the existing stove.

#### Cabinet & Drawers

New cabinets and drawer layout should be similar to the existing cabinet layout. The contractor should provide a dimensioned drawing of the proposed cabinets and drawers including the height, depth, and width of each item.

Cabinets doors should be flat (slab) face, acrylic with a medium, non-white color. The doors should be overlaid and designed to not require door or drawer handles.

Cabinet doors should be a neutral, non-white color complementary to the tiles and countertops.

#### Sink & Faucet

The bathroom sink should be a single bowl, undermount, white porcelain. Faucet should be chrome, high arc, single handle.

#### Floor drain

Any existing floor drain should be replaced with new condition and should not cause trip or foot cut.

#### Mirror & Medicine cabinet

The mirror should be on the front of medicine cabinets extending the entire length of the countertop. The medicine cabinet and internal shelves should be glass with a minimum depth of 4". Plastic is not acceptable.

#### Towel hangers and hooks

The bathroom should include 2 chrome bath towel bars, 2 chrome hand towel bars or rings, and 2 chrome wall hooks. Plastic is not acceptable.

#### Soap dish

The soap dish should be surface mount, white porcelain.

#### Toilet

Toilet should be tank-type, white porcelain, elongated bowl, with dual flush buttons on top of the tank. The seat height should be between 15" – 17" from the floor.

#### Toilet paper holder

The toilet paper holder should be chrome, surface mount. Plastic is not acceptable. Holder should be installed 26" above the floor, on center and 8.5" on center from the front of the front of the toilet bowl.

#### Bathtub & Shower

The new bathtub will be the same size as the original. Bathtub should be made of white porcelain with factory built-in anti-slip surface in the floor of the tub.

Bathtub plumbing hardware should be similar to the existing and should be made from chrome. Plastic is not acceptable.

The shower head should have a hose for hand-held operation with a minimum 59" hose. All components should be metal. Plastic fixture or plastic hose is not allowed.

#### Shower curtain rod & curtain

Rod should be metal and screwed into the wall. Plastic is not allowed. Compression curtain rods are not allowed. Curtain should have an inner plastic liner and an outer, neutral color fabric.

#### Exhaust fans

Replace bathroom exhaust fan with new fan with a gravity backdraft damper.

#### Window treatments

Furnish and install metal blinds in the existing window for privacy.

#### Lighting

Provide and install an LED lights of similar style and in the same locations as original lights. The LED light should be no less than 5000K color temperature.

All light or fan switches should have stainless steel wall plates with grey plastic rocker switch.

#### Electrical Work

In addition to the electrical work associated with the fan and lights the contractor shall replace all electrical outlets with GFCI outlets in GFCI outlets are not already installed. Additionally, there should be a total of 2 countertop GFCI outlets. The outlets will be provided by the Consulate, but all electrical work, wall cutting, patching, and painting will be by the Contractor. No exposed wires or surface mounted conduit is allowed. Wires should be buried inside the wall as necessary.

#### Painting

The entire bathroom should be patched and painted upon completion of the work.

#### **Maid Bathrooms:**

The same general specifications for the family bathrooms apply to the maids bathroom. The contractor should ask question in writing for clarification.

#### **Maid Room & Storage Room:**

##### Floor tile

Existing floor tile in the maid's room and the laminate tile in the storage room should be removed and replaced. New floor tiles should be porcelain (minimum Class 3), a non-white light neutral color, and should be no larger than 30cm.

Tile grout should be complementary to the tiles selected and should be the same for all tiles used. Non-white, neutral grout should be proposed.

Lighting

Provide and install an LED lights of similar style and in the same locations as original lights. The LED light should be no less than 5000K color temperature.

Floor drain

Any existing floor drain should be replaced with new condition and should not cause trip or foot cut.

New Ceiling

Replace the existing ceiling with a new ceiling to match the color and material of the old ceiling.

Utility Sink

Install a new utility sink and plumbing fixtures with the similar size as the existing sink. Fixtures should be chrome and not plastic.

Cabinets, shelving, clothes storage, etc...

Furnish and install new storage similar to existing. Material should be dark wood similar to the existing material. The Contractor should make a special attempt to provide as much storage as possible. Shelves should be of the appropriate strength to hold heavy boxes.

Painting

The rooms should be patched and painted upon completion of the work.

Sliding Doors

All sliding doors should be replaced with double pane, insulated, doors.

Light Switches & Wall outlets

The Contractor will replace all the light switches & electrical wall outlets with new white plastic covers. All switches and outlet plates should be approved by the Consulate prior to ordering. All electrical wire should be buried inside the walls. Exposed conduit is not allowed to the switch or to the lights/appliance is not allowed. Existing surface mounted conduit should be removed and the wires hidden in the wall.

**PRICE#2: WOOD FLOOR REPLACEMENT**

**Wood floors**

Remove all existing wood floor, entry tile, and carpet and replace with new wood floor. The new floor will match the attached specifications for Amazon teak wood. The wood pattern must be approved by the Consulate prior to purchase. The Contractor should replace all wood baseboards with new wood baseboards and paint to match wall paint color.

**PRICE #3 – REPLACEMENT OF EXISTING ELECTRICAL WIRES**

The Contractor should provide a separate price to remove all existing electrical wires and replace with new wires compliant with EMSD standards. The price will include all necessary demo,

wall/ceiling/floor cutting, wall repair, patching, painting, conduit as required by code, testing, and inspecting not included in PRICE #1.

3. **Material Storage and Debris Removal**

Material may be stored in a location acceptable to the USG upon request. All storage is for the convenience of the contractor and the responsibility for keeping the material safe and in good condition remains with the contractor. The material will be placed in such a way as to present no safety hazards to the Consulate or contractor's employees. All material shall be removed immediately upon the completion of this project.

4. **Warranties and Maintenance**

The Contractor shall complete and finish all work to the satisfaction of the USG and shall provide at least **ONE** years of warranty of the work. The contractor shall provide the maintenance requirements and specifications for any materials used.

5. **Safety Instructions**

The Contractor shall supervise and promote an accident-free working environment and suitable safety training to their workers, and shall follow all of the following safety regulations:

6. **Insurance**

The contractor shall provide Labor Compensation and Third Party Insurance coverage for the duration of the project.

7. **Working Hours**

The Contractor is allowed to work from 8:30 a.m. to 5:30 p.m. on WEEKDAY or indicated holidays work by COB. It is Contractor's own responsibility to work on the Weekend.

8. **Other Requirements**

The Contractor must keep the entire working area clean all the times and well protected from other working areas, and post all necessary warning signs in English and Cantonese. The contractor will be held responsible for any damages to the USG and private property.

9. **Drawings and Submittals**

The contractor should provide a full submittal package for all tiles, grout, ceiling, cabinets, fixtures, sinks, hood, tub, toilet, toilet paper holder, mirror, etc... for approval by the Consulate before ordering any materials.

The contractor should provide a fully dimensioned drawing showing a floor plan and section view of the bathrooms, kitchens, maids room, and storage rooms showing the size of each component, installation heights, locations, etc.. for review and approval by the Consulate. The Consulate may

make 2 review and changes to the drawings for the contractor to incorporate at no additional cost to the Consulate.

Drawing and submittal package should be delivered to the Consulate within 30 calendar days of the receipt of the purchase order.

*Foreign person* means any person other than a United States person.

*Specified Federal procurement payment* means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

*United States person* as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—
